## Positive Impact: Challenger Class

"To be able to access the Riverside Lounge with our pupils complex needs has been an amazing opportunity. It has given our pupils a chance to socialise, to experience being in a cafe and the skills that come with being in that environment. It's an experience that we will be repeating in the future to allow our pupils to gain independent skills that can be transferred to places beyond Riverside, whether that be embracing new environments or making choices using photographs of reference, the Riverside Lounge has opened a brand new opportunity for our pupils in many different ways."



## Positive Impact: Discovery Class

"The Riverside Lounge has provided an opportunity for the pupil's in Discovery class to experience a working role within the wider Riverside community.

Community based experiences have at times been challenging for some of our pupil's to access in a meaningful way, however the Riverside Lounge has created an inclusive working opportunity where there really is a role for every individual.

The 6 pupil's within Discovery class who access the Riverside Lounge have worked as part of a set up and clean up team, where they have practised life skills and gained new valuable skills which can be transferred to a range of settings. They are skills that can path the way to meaningful working roles within later life experiences and within their home environment.

The role that Discovery pupils have within the Riverside Lounge has been adapted to meet their existing skill set while still extending and challenging to support their progression. The level of support required has drastically reduced throughout their working experience and as a class (and school) we are so proud to watch these pupil's truly being all that they can be!"



## Positive Impact: Atlantis Class

"Atlantis pupils have shown courage, resilience and outstanding teamwork as they have embraced The Riverside Lounge. These invaluable work skills are preparing our young people for life after Riverside, where they will be able to transfer these important employability skills to a range of settings. ## Transition to Adult Social Care Services

## Adult Learning Disability Service







#### Adult Social Care Support for Young People aged 16 – 18 yrs

### Aged 16

- The transitioning from Children to Adult Services with learning disability and / or autism
- Children's Disability Service or Leaving Care Team inform Learning Disability team of possible needs of young person post 18 yrs.
- In complex cases consideration will be given to attending school reviews, meetings and Adult LD team may become involved with the young person.
- All current issues surrounding the young person remains the full responsibility of the Children's Disability Service until young person turns 18.



#### Adult Social Care Support for Young People aged 16 – 18 yrs

#### Aged 17

- A **transition assessment** will be offered to a young person who is likely to have support needs when they turn 18.
- The Adult Learning Disability social worker will contact the family for completion of the Care Act Assessment (assessment of needs) and aims to complete the assessment by 17.5 years of age.
- The assessment considers the young person's eligibility for services post 18 and identifies and 'care and support needs.
- Where a young person is not eligible for care and support within Learning Disability team the
  young person will be given information and advice about alternative sources of support or
  signposting e.g. to Bromley Well or other community partners.

**Note:** During the assessment process together we will discuss the options available, with the aim for these to be available when the young person reaches 18 years of age.



#### Outcomes for adults with care and support needs

Managing and maintaining nutrition

Maintaining personal hygiene

Managing toilet needs

Being appropriately clothed

Being able to make use of the home safely

Maintaining a habitable home environment

Developing and maintaining family or other personal relationships

Accessing and engaging in work, training, education or volunteering

Making use of necessary facilities or services in the local community, including public transport, and recreational facilities or services

Carrying out any caring responsibilities the adult has for a child.



# An adult meets the eligibility criteria

Their needs are caused by physical or mental impairment or illness – (this includes - physical, mental, sensory, learning or cognitive disabilities or illnesses, substance misuse or brain injury).

As a result of the adults needs, they are unable to achieve two or more specified outcomes

As a consequence there is or is likely to be a significant impact on the person's well-being:

## Financial assessment

Local authorities <u>must</u> inform individuals that a financial assessment will determine whether or not they pay towards their care and support, but this must have no bearing on the assessment process itself



#### Adult Social Care Support for Young People aged 18 – 19 yrs

### Aged 18

- Services or funding from the Children's Disability Service will continue to provide services (if available) until a decision is made on eligibility under the Care Act.
- Decisions of the Care Act Assessment will dictate agreed actions and ongoing short breaks/respite/day opportunities which should now be in place with visits to centres and services complete.



## **Direct Payments**

- Assessment will take place with social care
- Money paid from the borough, which you can use to arrange your own support.
- Pay for care and support in the home, short break and respites, getting out and about, support for carers, employing a personal assistant, equipment which helps young person to live independently.



## Short breaks

- All short breaks have to be assessed, some may require use of direct payments, some funding comes from the local authority

- Shared lives Carers who provide support in their own home

- Support with a range of services, including employing a PA, finding a PA,

#### Adult Social Care Support for Young People aged 18 – 19 yrs

#### Aged 19

- Education in special needs schools stops in July after the young person's 19<sup>th</sup> birthday.
- The Preparing for Adulthood Team should be aware of where the young person will be going from September after their 19<sup>th</sup> Birthday if education is continued. (Joint working is in place with the SEN service)

**Note:** If the young person isn't continuing to further education, there will be opportunity for the young person to engage in activities in the community. Social workers will be available to give information on support options available. Where the young person wishes to work, they will be signposted to appropriate agencies.



### Adult Social Care Support for Young People aged 19 – 23 yrs


#### Aged 19+

- Social Workers with a focus on transition from the Preparing for Adulthood team works with the young person up until the age of 23, when the transition to Adult Services (beyond college) has been completed.
- At 21-22 Care Act assessment will be updated.
- Social Worker will attends college reviews working with the young person to understand the future plan, whilst working closely with the family in supporting the outcomes for the young person – such as supporting at home, moving into supported living placement or appropriate placement.

**Note:** Once a young person is settled with a care package/appropriately placed in a provision, the young person will be supported by the wider adult learning disability team and reviewed on a yearly basis.

## Annual health check up: Year 9 onwards

- Annual health checks are being offered to everyone registered with a confirmed learning disability from the age of 14+.
- Local NHS services are working closely together to identify young people that will be eligible for this service at their local GP practice.
- For families and young people who would like to access this service, please speak to your GP.







## Advice and support for college placements

### Choosing a college ...

- Borough's have to consult with the specialist colleges they have in borough.
- This does not mean to say you can not state a preference for other colleges.
- Please take time to look round the colleges in borough and out of borough
- In Bromley we have Nido Volans centre part of London South East Colleges, also in Bromley is NASH college, run by liveability.
- We will support you as best we can, we know this is a huge transition for your child and for you!



### From years 9 - 13

- Every EHCP review you will be asked about preferences for colleges, this will be documented
- Look at websites
- Attend Open Days to get a feel of the colleges
- We will support you every step of the way.
- Express an interest with the college
- If your preference is residential college, ensure this is mentioned within EHCP reviews as early as possible, detailing reasons why this is a preference. Liaise with social care about this as well. Residential Colleges are joint funded from education and social care.



### Yr14 Transition Review

- September YR 14 transition review date of this will be given in July for current year 13's
- Preparation is key!
- Tell us who you would like to have there
- The EHCP is important please ensure this represents what you and your child feels should be detailed on there
- EHCP coordinator will be present at the review
- New outcomes will be discussed, have a think about these prior to the review meeting
- Placement preference to be discussed within the review, have an idea before coming to the review meeting and do as much research as you can beforehand.



### In Yr14

- College placements are confirmed from the local authority by 31<sup>st</sup> March.
- Different colleges have different transition programmes.
- We liaise closely with colleges throughout the year
- Transition will take place physically in the summer term for pupils, we can help support
- We will do work to start preparing pupils throughout the year with visual supports, discussions etc



### If you wish to appeal....

- If you wish to appeal the placement offer, you must start this within 15 days of receiving the letter.
- The panel sits and looks at EHCP, supporting statements and measures against the four preparing for adulthood outcomes:
  - Community inclusion developing friends, relationships, and sustainable networks of support.
  - Employment opportunities to experience the world of work and get paid employment.
  - Independent living maximising skills to live as independently as possible.
  - Good health maintaining good health and a healthy lifestyle
- In your appeal letter detail information against each of the four headings, and why your requested provision would support in reaching these outcomes, try not to focus on what you feel the provision that has been named doesn't offer
- Contact IASS (Independent Advisory Support Servcie)
- Mediation process will be started
- It might result in going to formal panel meeting

# Every family's situation will be different – you can seek guidance from our Community Outreach Workers re your individual circumstances





### **DLA to PIP**

- Prior to your child's 16<sup>th</sup> birthday, you will receive a letter from the DWP
- It explains that DLA will stop at their 16<sup>th</sup> birthday, but a PIP claim can be started
- The PIP claim does not happen automatically, you must call to start your claim





### **PIP Process**

- Call the DWP to start the claim
- You will receive a PIP Form to complete
- You will be invited to a face to face assessment
- An award decision will be posted to you.





### **Financial Appointees**

- At 16 years your child will require a financial appointee
- You will receive a letter asking your child to nominate a suitable representative
- The DWP may follow up with a visit or telephone meeting
- The financial appointee is responsible for managing the person's welfare benefits only





### **ESA/Universal Credits**

A claim for Income Related Employment and Support Allowance can be made if your child is in receipt of PIP and not in employment.

- Call the DWP to start the claim
- Seek a medical certificate from your GP to state your child is not 'able to work' at this point
- You will be sent a Capability for Work Assessment form
- If your claim is successful you will either be in the work related or support group.

Note: as the claimant will be receiving benefits in their own right, this could impact other benefits for the family, ie, child benefit – it is advisable to do a welfare benefit check before proceeding.
